LIMITED WARRANTY

TRUSTAIN FINISHING SYSTEM FOR USE ON FIBERGLASS DOORS

TRUSTAIN FINISHING SYSTEM (“TruStain”) applied on the door slab is warranted against flaking, checking, blistering or peeling for a period of ten (10) years from the date of installation and on the exterior of the wood frame is warranted against flaking, checking, blistering or peeling for a period of ninety (90) days from the date of installation.

This warranty is only for the TruStain and not the door upon which the finishing system is applied. This warranty is only given to the original consumer purchaser and only applies when the door is installed in a single family residence.

NON-RESIDENTIAL APPLICATIONS: Where the structure in which the product is installed is not a single family residence or a home occupied by the original consumer purchaser and is owned by a public or private corporation for profit or non-profit, an unincorporated association or other business entity of any type recognized by law, a church, a school, a government or public authority, TRUSTAIN on the door slab is warranted against flaking, checking, blistering or peeling for a period of one (1) year from the date of installation.

COASTAL APPLICATIONS: When TruStain is installed in a Coastal region, the stain finish on the door slab is warranted against flaking, checking, blistering or peeling for a period of five (5) years from the date of installation.

EXTREME EXPOSURE APPLICATIONS: When TruStain is installed in an Extreme Exposure Region, the stain finish on the door slab is warranted against flaking, checking, blistering or peeling for a period of four (4) years from the date of installation. The following states are considered to be Extreme Exposure Regions: AK, FL, HI, ID, MT, ND, NM, NV, OR, SD, UT, WA, and WY.

No warranty herein covers damages resulting from improper installation, abuse, negligence, abnormal or unreasonable use (including failure to provide reasonable and necessary maintenance), damages resulting from fire or lightning, windstorms, earthquakes, wind-borne objects, strain applied to the unit by movement of the building, inadequate provision for expansion or contraction or framing members, installation in ships or vehicles, seal failure (if the seal has been subject to immersion in water), acts of God, or other causes beyond the control of AquaSurTech OEM. Finishes can be affected by varying degrees of exposure to the weather and should not be viewed as “maintenance free”.

The sole procedure for obtaining performance of the obligations of this warranty is as follows: if the consumer purchaser believes the TruStain as installed is defective, the consumer purchaser must

contact the contractor who supplied the door. The contractor must then contact and review the matter with AquaSurTech OEM. If AquaSurTech OEM determines that the TruStain as installed does not conform to the limited warranties herein, the consumer purchaser's sole remedy will be that AquaSurTech OEM will provide the purchaser with replacement TruStain product of equal value. AquaSurTech OEM reserves the right to discontinue or make changes in any of its products. If the product covered by this warranty is no longer available, AquaSurTech OEM shall have the right to substitute a product that is of equal value. AquaSurTech OEM will ship the replacement product to the purchaser and the purchaser must pay for any and all labor necessary to install the replacement product, including removal of the original product.

AQUASURTECH OEM SHALL NOT BE LIABLE TO PURCHASER FOR CONSEQUENTIAL OR OTHER DAMAGES, SUCH AS, BUT NOT LIMITED TO, DAMAGES OR LOSS TO OTHER PROPERTY OR EQUIPMENT, LOSS OF USE, OR CLAIMS OF SERVICE INTERRUPTION, OR FOR BREACH OF ANY WRITTEN OR IMPLIED WARRANTIES ON ITS PRODUCTS. PURCHASER'S EXCLUSIVE REMEDY SHALL BE THE REPLACEMENT OF DEFECTIVE FINISH ALL AS PROVIDED HEREIN. IN ANY EVENT, THE LIABILITY OF AQUASURTECH OEM HEREUNDER SHALL NOT EXCEED THE ORIGINAL PRICE OF THE TRUSTAIN PRODUCT.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to purchaser.

THIS WARRANTY CONTAINS THE ENTIRE AGREEMENT BETWEEN AQUASURTECH OEM AND THE CONSUMER PURCHASER. DEALERS, CONTRACTORS, APPLICATORS, OR DISTRIBUTORS OF AQUASURTECH OEM PRODUCTS HAVE NO AUTHORITY TO GIVE WARRANTIES ON AQUASURTECH OEM'S BEHALF THAT ARE DIFFERENT FROM OR EXCEED THOSE LISTED HEREIN. A CONSUMER PURCHASER SHOULD THEREFORE EXAMINE THIS LIMITED WARRANTY CAREFULLY. ALL WARRANTIES, WHETHER EXPRESSED OR IMPLIED, WARRANTIES OF MERCHANTABILITY OF FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED TO THE TERMS HEREOF.

Some states do not allow limitation on how long an implied warranty lasts, so the above limitation may not apply to purchaser. This warranty gives purchaser specific legal rights and purchaser may also have rights which vary from state to state.

Any claim asserted under any provisions of this warranty must be accompanied by a copy of the proof of purchase of TruStain product. The consumer purchaser should maintain this item in a safe place.
